OUTCOME/RESULTADO:

You are **DENIED** benefits on this claim.

This DENIAL begins on February 23, 2020. Your denial ends when you receive payment from an employer(s) in the amount of four (4) times your weekly benefit amount for work you do in future weeks. Proof of earnings may be required. In addition, your maximum benefit amount may be reduced by eight (8) times your weekly benefit amount.

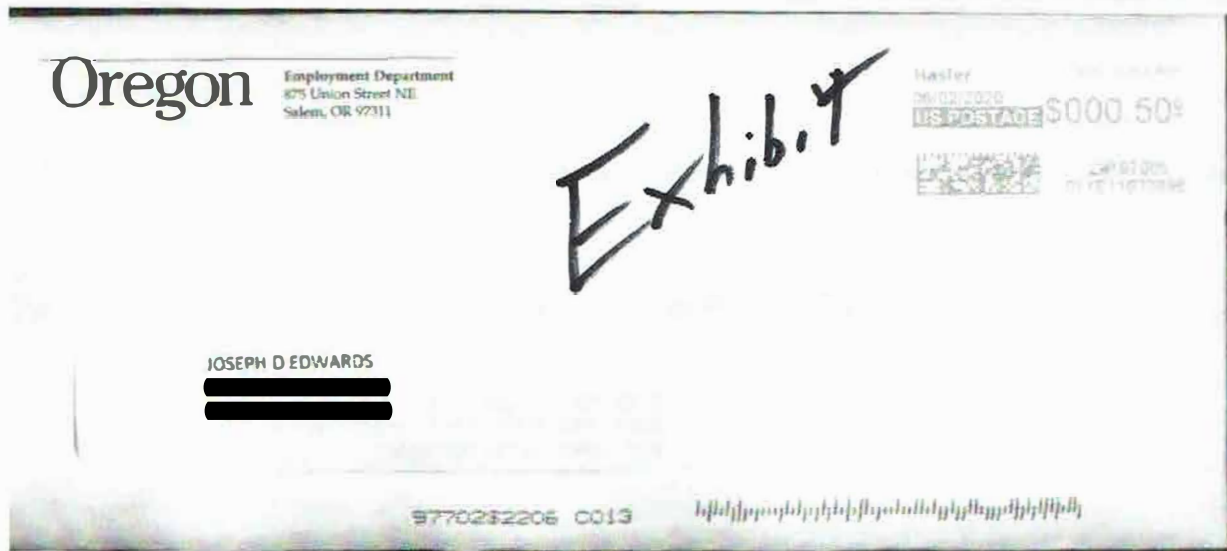
